The purpose of this letter is to invite you to send a representative to a 1-day fuel regulators meeting at U.S. NRC headquarters in Rockville, Maryland, on October 25, 2001. The meeting date was selected to follow the Nuclear Safety Research Conference, which ends October 24, 2001. All the participants of the first fuel regulators meeting, held in October of 2000, expressed their belief that the meeting was very beneficial and encouraged follow-on meetings.

The purpose of this meeting is to exchange information and obtain feedback on issues related to regulation of nuclear fuel. This year's meeting will emphasize mixed-core and mixed-oxide fuel regulation. It will provide an opportunity for fuel regulators to discuss the everyday details of their processes and methods of implementation. The expected outcome is a better understanding of how other regulatory bodies handle mixed-core and mixed-oxide fuel issues, which will help all participants in their decisions on these nuclear fuel issues. A draft agenda is attached.

I hope that your staff responsible for regulation and licensing of nuclear fuel will be able to attend this meeting. Regulatory information exchange meetings like this are of important and I hope that we will have many more opportunities for such interactions.
