The letter requested that the NRC complete the review of the TR by June 30, 2002. It also requested, consistent with NRC Office of Nuclear Reactor Regulation Office Instruction LIC-500, "Processing Requests for Reviews of Topical Reports," that the NRC provide an estimate of the review hours, as well as target dates for any requests for additional information (RAIs) and for completion of the safety evaluation (SE) for the TR.

The NRC staff has performed an acceptance review of the TR. The staff has determined that it meets the criteria in LIC-500 for acceptance for staff review and that it is complete enough for the staff to begin a technical review. The staff expects to issue RAIs (if any) by December 10, 2001. The staff estimates that the review will require approximately 220 review hours, and the target date for issuance of the SE will be May 31, 2002. The review hour estimate does not include time required to coordinate the review and develop and issue the SE. To enable the staff to complete the review on the schedule requested by the WOG, close and frequent communications between our technical staffs will be required.
