On September 19, 2001, representatives of Entergy Nuclear Operations, Inc., (ENO) met with the NRC staff in Rockville, Maryland. ENO had requested this meeting in order to brief the NRC staff on its plans to develop a common quality assurance (QA) manual for the northern ENO owned nuclear plants consisting of FitzPatrick, Indian Point 3, Pilgrim, Indian Point 2, and northern plants of future acquisitions by ENO. A list of attendees is provided in Enclosure 1 and a copy of the handouts provided by ENO is provided as Enclosure 2.

The licensee's reason for the meeting was to inform the staff of their planned development of a common QA manual for its northern plants patterned after the common QA manual that is in place for its southern plants. ENO QA manual for the southern ENO owned nuclear plants has been accepted by the NRC staff. ENO anticipates that the proposed common QA manual for the northern plants will not decrease the effectiveness of the current manuals and, thus, need not be submitted for NRC formal approval. ENO plans to submit a common QA manual applicable for all northern plants in one submittal for all the dockets. The exact schedule for the submittal has not yet been established.
