The subject task order expired on July 13, 2001. According to our records, there are funds remaining under this task order in the amount of \$55,786.71 which are unexpended. Pending completion of all closeout requirements, it is necessary to de-obligate a portion of the excess funds in the amount of \$33,319.46 for other immediate Agency requirements. Funds in the amount of \$22,467.25, which represent estimated adjustments for final indirect rates prior to the novation of the contract, will be retained under the task order pending final closeout of the contract. This revised modification supercedes the original Modification No. 4 which did not address de-obligation and/or retention of funds for final indirect rate adjustments.


