By letter dated September 18, 2000, the staff approved relief requests for the use of the 1998 edition of subsections of IWE and IWL of the ASME code for containment inspections. The relief requests were issued for Byron, Units 1 and 2, Dresden, Units 2 and 3, and LaSalle, Units 1 and 2.

The TAC numbers associated with those reviews were closed immediately after the relief approvals were issued.
