Here is the data from COMPLY. This is for 1999, 2000, and year to date 2001. Just a reminder that the effective AEC in my spreadsheets already accounts for the 10 mrem or 20% of the Table 2

effective AEC. Therefore in my summary table the fraction of the AEC relates to the concentration that would result in a dose of 10 mrem. With this in mind I don't believe there is a requirement to run COMPLY.

I think this and the Hehl letter address the questions to date. Let me know if you need anything else to wrap up the inspection report.
