**SUBJECT: PUBLIC DISCLOSURE DETERMINATION**

I am responding to your letter and affidavit dated May 15, 2001, requesting that a decommissioning cost estimate for the Parks Facilities Decommissioning Project be withheld from public disclosure pursuant to 10 CFR 2.790(a)(4) of the Commission's regulations.

We have reviewed your application and all the supporting information in accordance with the requirements of 10 CFR 2.790 and have concluded that you have not provided sufficient justification for us to determine that the information sought to be withheld from public disclosure contains trade secret, proprietary, or confidential commercial or financial information.


Pursuant to 10 CFR 2.790(b)(1)(ii), the affidavit accompanying the application must contain "a full statement of the reasons on the basis of which it is claimed that the information should be withheld from public disclosure." In addition, "Such statement shall address with specificity the considerations listed in [10 CFR 2.790(b)(4)]." Your affidavit did not provide a full statement of the reasons on the basis of which the claim was made, nor did it address the considerations of 10 CFR 2.790(b)(4).

Accordingly, we have concluded that the information sought to be withheld from public disclosure does not meet the requirements of 10 CFR 2.790. Therefore, your request to withhold the decommissioning cost estimate for the Parks Facilities Decommissioning Project from public disclosure is denied.
