The petitioner requested that the Commission eliminate rulemaking as the approval mechanism for Certificates of Compliance (CoC) for dry cask storage of spent nuclear fuel under a general license. Rulemaking would be replaced with a process using orders. The petition was docketed as PRM-72-5.

The Commission is denying the petition for rulemaking because (1) improvements in the approval process since submittal of the NEI petition have significantly decreased the length of time for approval of CoC amendments, making regulatory change unnecessary; (2) the petitioner's approval process may require the offer of an opportunity for a hearing, which could eliminate any efficiency obtained by the elimination of notice and comment rulemaking; and (3) the Commission's performance goals would be better served by retaining the present process than by adopting the process suggested by petitioner.
