On March 27, 2000, the Commission issued Amendment No. 135 to Facility Operating License No. NPF-30 for the Callaway Plant, Unit 1. The amendment was in response to your application dated January 14, 2000 (ULNRC-04172), as supplemented by the letter dated February 17, 2000 (ULNRC-04187). Page 1.1-6 of the technical specifications (TS) that modified the definition for staggered test basis in Section 1.1, "Definitions," was part of the amendment.

By letter dated November 30, 2001 (ULNRC-4573), you stated that Amendment No. 135 introduced an error to the TS in that the definition for slave relay test, which was not part of the amendment, was inadvertently changed by leaving out two phrases in the definition.
