Dear Mr. Simpson:

The purpose of this modification is to provide the allowable balance of funding for FY 2002.

Therefore, Articles II and III of the above subject Interagency Agreement are modified as follows:

Article II - Payment by the NRC to DOS

Available funds may be shifted, by the NRC, within the total available, by both Job Code and BOC, to adjust to actual expenditures.
