SUBJECT: REQUEST TO BE PLACED ON DISTRIBUTION FOR WESTINGHOUSE  
OWNERS GROUP EMERGENCY RESPONSE GUIDELINES AND RELATED  
DOCUMENTS

Dear Mr. Bischoff:

Whenever it is available, the U.S. Nuclear Regulatory Commission (NRC) Technical Training Center (TTC) staff makes extensive use of up-to-date technical information from direct sources to augment students understanding of reactor operations. The Westinghouse Owners Group (WOG) Emergency Response Guidelines (ERGs) have, for several years, been a very important part of initial and refresher training for NRC inspectors and operator licensing examiners. However, the copies of the ERGs available to the TTC have come from several unofficial sources and on occasion have been found to be outdated.

The NRC staff believes it important for quality of training that the TTC be on direct, official distribution for the following documents:

- WOG ERGs - Latest versions for high-pressure and low-pressure systems
- ERG Maintenance Items
- Severe Accident Management Guidelines (SAMGs)
- Abnormal Response Guidelines (ARGs)

There are several groups within NRC that have also expressed a need for these documents. Therefore, it is requested that the NRC be provided with six sets of the documents listed above. The documents would be most useful if also provided in electronic format. The ERGs for Combustion Engineering and General Electric have been placed on the NRC internal training web site, with the respective Owners Group's approval, for use by NRC employees. The staff requests WOG approval to also place the WOG ERGs on the internal training site.
