On December 5, 2001, the NRC staff met with representatives of TVA, the licensee for the Browns Ferry Nuclear Plant, Units 2 and 3 (BFN), at the NRC offices in Rockville, Maryland. The purpose of the meeting was to discuss the possible content of a future amendment to the licenses of BFN Units 2 and 3 for extended power uprate. Enclosure 1 lists the meeting participants. Enclosure 2 is a copy of the overhead slides that the licensee presented during the meeting.

The planned amendment will be for an extended power uprate for each unit to 3952 MWt, which would be approximately 15 percent above the current licensed power level of 3458 MWt. A previous uprate provided approximately a 5 percent increase above the original licensed power level. This would represent a total uprate of approximately 20 percent above the original licensed power level of 3293 MWt.

During the meeting, the NRC staff discussed various aspects of the review with the licensee, including major plant modifications, proposed submittals and schedule. The submittal will be based on a full implementation of the General Electric Constant Pressure Power Uprate topical report, which is currently under review by the NRC staff. The main submittal is scheduled for submission in July 2002.
