On May 31, 2001, NRC issued an annual assessment letter covering the period from April 2000 to March 2001. This letter contained a preliminary schedule of NRC engineering inspections through April 2002. Due to changes in the baseline inspection program, Inspection Procedure 71111.02 is no longer required to be performed annually. Therefore the Changes, Tests and Experiments inspection scheduled for March 4 -8, 2002, will not be done. This inspection will be included in a future Permanent Plant Modifications inspection. Additionally, due to emerging issues, and circumstances unforeseen when the schedule was developed, we have decided to delay the upcoming LaSalle Heat Sink inspection. The original dates for this inspection were March 18 - 22, 2002. The new dates for the inspection are April 1 - 5, 2002.
