DATES OF VISIT: December 6, 2001

PURPOSE OF VISIT: Meet with resident inspectors and meet with licensee management

INSPECTORS OBSERVED: Ted Easlick

SENIOR LICENSEE PERSON CONTACTED: Jack Keenan, Brunswick Vice President

OBSERVATIONS NOTED WITH PLANT: Made a comprehensive tour of the plant with Ted Easlick. Overall the plant looked in good condition. Noted in particular that the maintenance to the manholes on site had been successful. This maintenance is still on-going. Several buildings where there had been standing water on the floor due to leakage through the electrical conduits were now water free. This was due the sealing of the conduits in the manholes. Also reviewed completion of the baseline inspection program with the residents. Also discussed with residents the licensees plans to correct the emergency diesel valve seat insert problem.

OTHER COMMENTS: Met with Jack Keenan. Keenan commented on communications between the licensee and the resident staff remains very good. He had no issues with the NRC.
