

The purpose of this modification is to obligate funds in the amount of \$1,942.95 for payment of the final retained fixed fee pursuant to the contractor's (Joan L. Cheevers) letter dated 9/21/1999. Accordingly, the contract is modified as follows:

1. The total amount obligated is increased by \$1,942.95 from \$172,929.11 to \$174,872.06. Section B.3 CONSIDERATION AND OBLIGATION--COST PLUS FIXED FEE, paragraph (c) is deleted in its entirety and replaced with the following:

(c) The amount obligated by the Government with respect to this contract is \$174,872.06.
