The purpose of this modification is to obligate FY 2002 funds in the amount of \$200,000.00, thereby increasing the obligated amount of this contract from \$780,000.00 to \$980,000.00. Accordingly, the contract is hereby modified as follows:

Under Section B., subsection B.2, "CONSIDERATION AND OBLIGATION-DELIVERY ORDERS (JUNE 1988," the first sentence in paragraph "(b)" is revised to read as follows:

"(b) The amount presently obligated with respect to this contract is \$980,000.00."

All other terms and conditions of this contract remain unchanged, including the contract ceiling amount of \$1,121,000.00.
