The purpose of this modification is to provide incremental funding in the amount of \$46,641.60, thereby, increasing the obligated amount from \$30,000.00 to \$76,641.60 and fully funding the contract. Accordingly, the contract is modified as follows:

Under Section B.3.6, CONSIDERATION AND OBLIGATION-DELIVERY ORDERS the first sentence of Paragraph (b) is deleted entirely and replaced with the following:

“(b) The amount presently obligated with respect to this contract is \$76,641.60.”

All other terms and conditions of this contract remain the same, including the contract ceiling amount of \$76,641.60.
