

The primary purpose of this modification is to provide incremental funding in the amount of \$500,000, thereby increasing the obligated amount from \$826,000 to \$1,326,000. In addition, the secondary purpose of this modification is to correct two (2) inadvertent administrative errors made on Modification No. 3 regarding the B&R Number and the Job Code. The correct B&R Number is 26015110203 and the correct Job Code is Y6215. Accordingly, the following change is hereby made under Modification No. 4:

Section B.3, CONSIDERATION AND OBLIGATION—COST PLUS FIXED FEE (JUN 1988) ALTERNATE I (JUN 1991), paragraphs (e) and (f) are hereby deleted in their entirety and replaced with the following:

"(e) The amount currently obligated by the Government with respect to this contract is \$1,326,000, of which the sum of \$1,250,943.30 represents the estimated reimbursable costs, and the sum of \$75,056.70 presents the fixed fee.

(f) It is estimated that the amount currently allotted will cover performance through September 24, 2002."

A summary of obligations for this contract, from award through the date of this action, is provided below:

Total FY01 Obligation Amount	\$ 726,000
Total FY02 Obligation Amount:	\$ 600,000
Cumulative Total of NRC Obligations	\$1,326,000

This modification obligates FY02 funds in the amount of \$500,000.

All other terms and conditions, including the ceiling of \$1,728,494, remain the same.
