The purpose of this modification is to (1) provide for Conger & Elsea, Inc.'s presentation of Two-Day Root Cause/Incident Investigation Refresher Training Courses in the NRC Regions, Headquarters, and the Technical Training Center (in accordance with Section B.3.9 of the contract); (2) increase the contract cost ceiling by \$130,640 from \$757,465 to \$888,105; and (3) increase the total obligated funds by \$12,000 from \$381,933 to \$393,933.

Accordingly, the following Sections of the contract are hereby modified:

1. Section B.8 SUPPLIES OF SERVICES AND PRICES/COSTS is revised to add the presentation of Two-Day Root Cause/Incident Investigation Refresher Training Courses as described in the attached Statement of Work and the contractor's proposal for this requirement. Therefore, Section B.8 is modified to add the following subsection:

3. Section A.2 - Consideration and Obligation — Delivery Orders (Jun 1988), first sentence of Subsection (2), as modified in Modification No. 3, is deleted and substituted with the following in lieu thereof:

"The amount presently obligated with respect to this contract is \$393,933.00."
