The purpose of the modification is to (1) divide CLIN 004 into CLIN 4a for a three month period and CLIN 4b for a nine month period, (2) exercise and fund CLIN 4a and (3) adjust the contract unit price of CLINs 4a and 4b pursuant to FAR 52.222-43 in accordance with Wage Determination dated 7/2/2001, and (4) adjust the total contract price and extend the duration of the contract. Accordingly, the contract is hereby modified as follows:

1. In accordance with Section C.4 of the contract, CLIN 004 is hereby revised as shown below and CLIN 4a is exercised.

As a result of the above, the total contract price is increased by \$151,026 from \$1,164,516 to 1,315,542. In addition the following section is added to the contract at Section B.6.

B.6 CONSIDERATION AND OBLIGATION - FIRM FIXED PRICE

The firm fixed price of the contract for the period set forth in B.5 is \$1,315,542. Contract prices for future option periods are set forth in Section B.3.

2. Furthermore, Section B.5 Duration of Contract is replaced with the revised version shown below:

B.5 Duration of Contract Alternate 2 (MAR 1987)

This contract commenced on 12/1/1999 and will expire on 2/28/2002. The term of this contract may be extended at the option of the Government for additional periods as shown in Section B.3.

3. The attached SCA wage determination 94-2103 Revision No. 23 is added to Section D of the contract as Attachment No. 3 for the period 12/1/01 to 11/30/02.
