Comanche Peak Steam Electric Station, Units 1 and 2

On December 21, 2001, the NRC staff issued an Order approving the transfer of the facility operating licenses from TXU Electric Company to TXU Generation Company LP. The license transfers were requested by the licensee, by application dated June 19, 2001, to comply with a Texas law requiring the separation of electric utility assets associated with generation, distribution, and sales. The actual transfer took place on January 1, 2002.

Grand Gulf Nuclear Station

On December 20, 2001, the NRC issued an exemption to specific requirements of Title 10 of the *Code of Federal Regulations* (10 CFR), Part 50, Appendix E, Sections IV.F.2.b and c., for Grand Gulf Nuclear Station, Unit 1. This action was in response to the licensee's request for a one-time exemption from the requirement to conduct a full-participation exercise of the offsite emergency plan every two years. The licensee requested rescheduling the biennial full-participation exercise, originally planned for September 17, 2001, because of the impact of the national emergency on September 11, 2001.

The exemption provides temporary relief. The licensee committed to conduct the exercise during the next calendar year (currently scheduled for March 2002), and has not requested any permanent changes in future biennial exercise scheduling. Accordingly, the licensee is expected to conduct another full-participation exercise of onsite and offsite emergency plans in 2003.

South Texas Project Electric Generating Station, Units 1 and 2

On December 20, 2001, an Order was issued authorizing the transfer of Reliant Energy Incorporated's (formerly known as Houston Lighting and Power Company) interest in the Facility Operating Licenses for South Texas Project Electric Generating Station, Units 1 and 2 (STPEGS) to CenterPoint Energy, Inc., a new parent holding company for Reliant. The Order also authorized the transfer of Reliant's interest in STPEGS to Texas Genco LP, which will be wholly-owned by CenterPoint Energy, Inc.

Exemption Issued for Three Mile Island-2 Independent Spent Fuel Storage Installation

On December 27, 2001, the Spent Fuel Project Office issued an exemption to the Department of Energy (DOE) for the Three Mile Island-2 Independent Spent Fuel Storage Installation. DOE had requested an extension of time in which to perform the 2001 Emergency Preparedness onsite exercise, which had been scheduled for September 12, 2001, and was postponed due to the events of September 11, 2001. DOE plans to conduct the exercise in the second quarter of 2002.

Four Draft Regulatory Guides Issued on ASME Code Cases

The Office of Nuclear Research (RES) has issued four draft regulatory guides that list or discuss the American Society of Mechanical Engineers (ASME) Code Cases that are acceptable to the NRC staff. Draft Regulatory Guide DG-1089, "Operation and Maintenance Code Case Acceptability, ASME OM Code," is a draft of a new guide on the operation and maintenance code cases that are acceptable to the NRC staff. Draft Regulatory Guide DG-1090, "Design, Fabrication, and Materials Code Case Acceptability, ASME Section III," is a proposed Revision 32 of the combination of Regulatory Guides 1.84 and 1.85. Draft Regulatory Guide DG-1091, "Inservice Inspection Code Case Acceptability, ASME Section XI, Division 1," is a proposed Revision 13 of Regulatory Guide 1.147. Draft Regulatory Guide DG-1112, "ASME Code Cases Not Approved for Use," is to become a new regulatory guide that is being developed for the convenience of the NRC's licensees, applicants, and stakeholders.
