Subject: **Revised Instructions for Control of Sensitive Information**

Dear Controlled Copy Holder:

As a result of ongoing world events, it has become necessary to distribute revised instructions for the distribution and handling of documents pertaining to Arkansas Nuclear One (ANO). The following guidance is provided to ensure that the information contained in the ANO documents currently in your possession is available only to the intended users.

- For CD-ROM copy holders, do not reproduce CD-ROMs
- Destroy CD-ROMs that are superseded, by cutting up the disc
- For paper copy holders, ensure that all pages removed from copies (as a result of an update) are shredded or destroyed by appropriate methods.
- Keep all copies in a secure location and only allow personnel access to the information on a need-to-know basis. The documents in your possession are for your official use only and are not public records. Please do not allow unauthorized access to these documents.
- Report any loss or theft of information to the contact noted below:

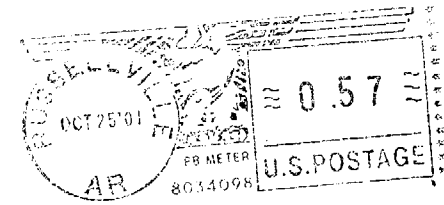
