Gentlemen:

The purpose of this letter is to provide additional information to the NRC Staff in support of TXU Electric Company's ("TXU Electric's") Application as previously submitted (see letter referenced above).

In the Application, TXU Electric requested that the Nuclear Regulatory Commission ("NRC") consent to the direct transfer of control of TXU Electric's operating authority and 100% ownership interest in the Comanche Peak Steam Electric Station, Units 1 and 2 ("CPSES") on January 1, 2002, to a Texas limited partnership. The name of the new TXU company entity (new licensee) had not been determined at the time of submittal of the Application. Therefore, the Application temporarily identified the new licensee as "TXU Genco, TLP" with a statement that the new licensee company name would be identified later. The Application also contained a simplified organizational diagram depicting the corporate structure for TXU Genco, TLP. The Application stated that names for the affiliated corporate entities described in the Application and the simplified organizational diagram, except for TXU Corporation, had not been selected and that TXU Electric would inform the NRC when names for these entities had been determined.

In response to this commitment, TXU Electric herein identifies that the new licensee for CPSES will be "TXU Generation Company LP". Accordingly, each description of "TXU Electric" in the current effective CPSES Operating Licenses should be replaced with "TXU Generation Company LP" at the time of the effective transfer of the licenses. Additionally, the names for the affiliated corporate entities related to TXU Generation Company LP in the Application's simplified organizational diagram have been determined and are identified in the attachment.

The Application is otherwise unchanged by this submittal. The original "Safety Analysis" (Attachment 1 of the Application) which includes the "No Significant Hazards" evaluation remains valid.


This communication contains no new licensing basis commitments regarding CPSES Units 1 and 2.

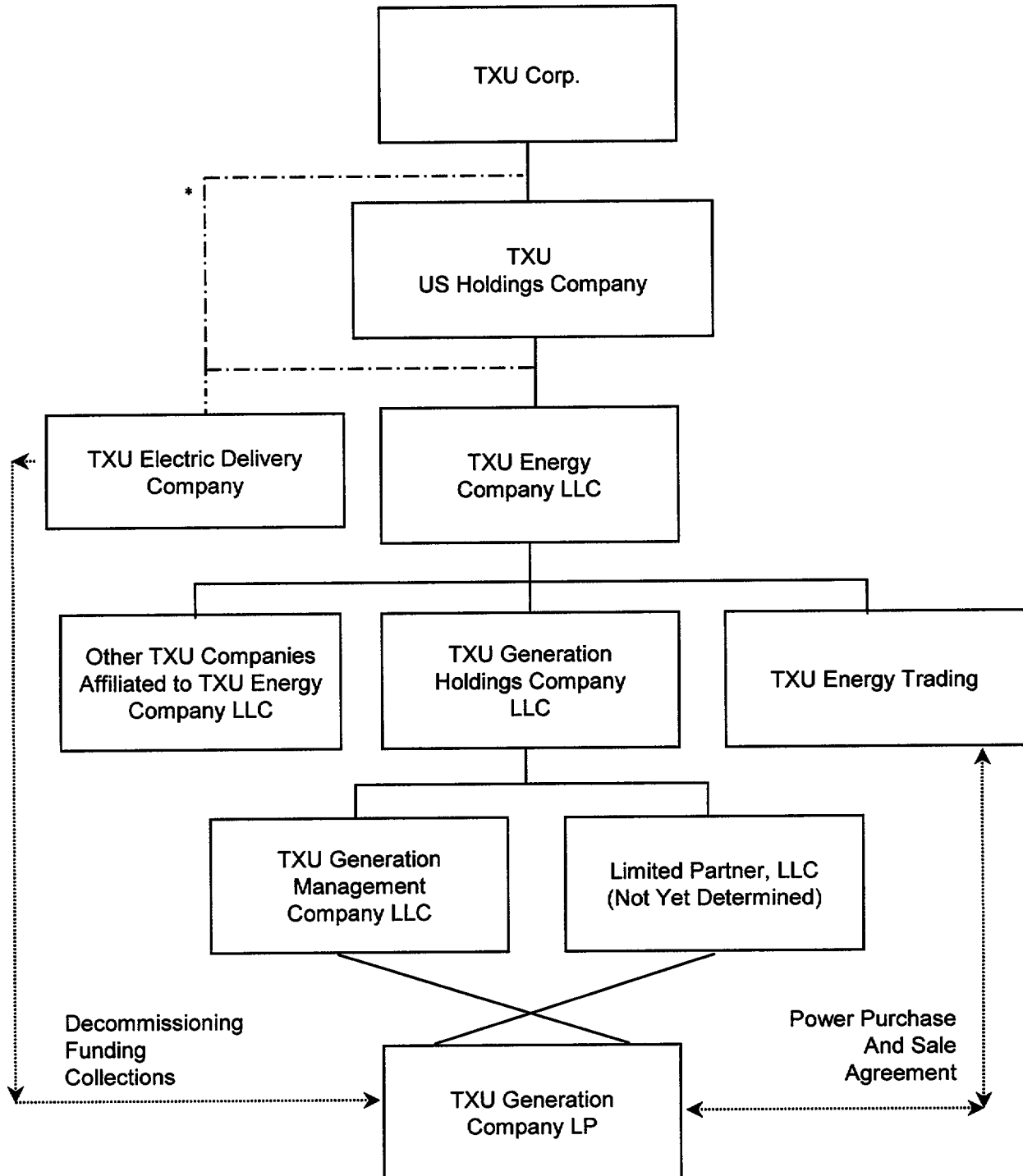
