OCCUPATIONAL DOSE FOR INDIVIDUALS EXPOSED TO BYPRODUCT MATERIAL AND
MEDICAL FLUOROSCOPY (STP-02-005)**

A document, concerning evaluation of occupational doses when both NRC regulated material and medical x-ray fluoroscopy are being used, has been uploaded to the NRC's Technical Conference Forum (TCF) for your review and comment.*

We are requesting your review and comment on a draft Regulatory Issue Summary (RIS) that addresses a personnel monitoring compliance issue. This draft RIS will provide guidance for determining doses to individuals who receive exposures to medical x-ray fluoroscopy, while wearing a lead apron. Early sharing of this draft RIS is for the purpose of collecting comments and addressing any issues raised prior to distributing the RIS to licensees.
