Gentlemen:

The purpose of this letter is to provide additional information to the NRC Staff in support of TXU Electric Company's ("TXU Electric's") Application as previously submitted (Reference 1).

In the Application, TXU Electric requested that the Nuclear Regulatory Commission ("NRC") consent to the direct transfer of control of TXU Electric's operating authority and 100% ownership interest in the Comanche Peak Steam Electric Station, Units 1 and 2 ("CPSES") on January 1, 2002, to a Texas limited partnership. The name of the new TXU company entity (new licensee) had not been determined at the time of submittal of the Application, but was later identified as "TXU Generation Company LP" (Reference 2).

This letter provides additional information related to the Application and organization of TXU Generation Company LP within the TXU corporate organization. Information provided herein is as follows: (1) updated corporate organizational diagram for TXU

Generation Company LP; (2) clarification statement concerning Application Section IV. - Foreign Ownership or Control; (2.a and 2.b) names/titles of affiliated company senior management executives; (3) effective date required for transfer of the CPSES operating licenses; (4) a statement of other approvals required with regard to the effective date of TXU Generation Company LP; (5) description and organizational chart for the CPSES Nuclear Overview function; and (6) evidence of transfer of TXU Electric's interest in nuclear insurance for CPSES to TXU Generation Company LP. This information is provided in Attachment 1.

The Application is otherwise unchanged by this submittal. The original "Safety Analysis" (Attachment 1 of the Application) which includes the "No Significant Hazards" evaluation remains valid.

2. Clarification Statement Concerning Application Section IV. - Foreign Ownership or Control

The Board of Directors of TXU Corp. includes ten members, nine of whom - including the Chairman and Chief Executive, Mr. Erle Nye - are citizens of the United States. Among the principal executives of TXU Corp., Mr. Brian Dickie, Executive Vice President, is not a citizen of the United States.<sup>1</sup> Mr. Dickie reports to the TXU Board through senior officers, including Mr. Nye. Accordingly, TXU Corp. is not subject to foreign ownership or control. TXU Generation Company LP, the licensee, will be an indirect, wholly owned subsidiary of TXU Corp.

A majority of each of the boards of directors or managers of each of the intermediate holding companies between TXU Corp. and TXU Generation Company LP, including the Chairman of the Board and Chief Executive of each, will be citizens of the United States. These individuals are drawn from the boards of directors or officers of TXU Corp. or its subsidiaries.

The Managers of TXU Generation Management Company LLC, which will be the General Partner of TXU Generation Company LP and will manage its affairs, are drawn from the boards of directors or officers of TXU Corp. or its subsidiaries. A majority of those Managers,<sup>2</sup> including the Chief Executive and Chairman of the Board, Mr. Nye, are citizens of the United States. The principal officers of TXU Generation Management Company LLC, who are also drawn from TXU Corp. or its subsidiaries, are citizens of the United States. Therefore, TXU Generation Company LP will not be subject to foreign ownership or control.

Except for approval of the NRC, TXU Electric has received all other approvals required and requires no other formal approvals prior to January 1, 2002.

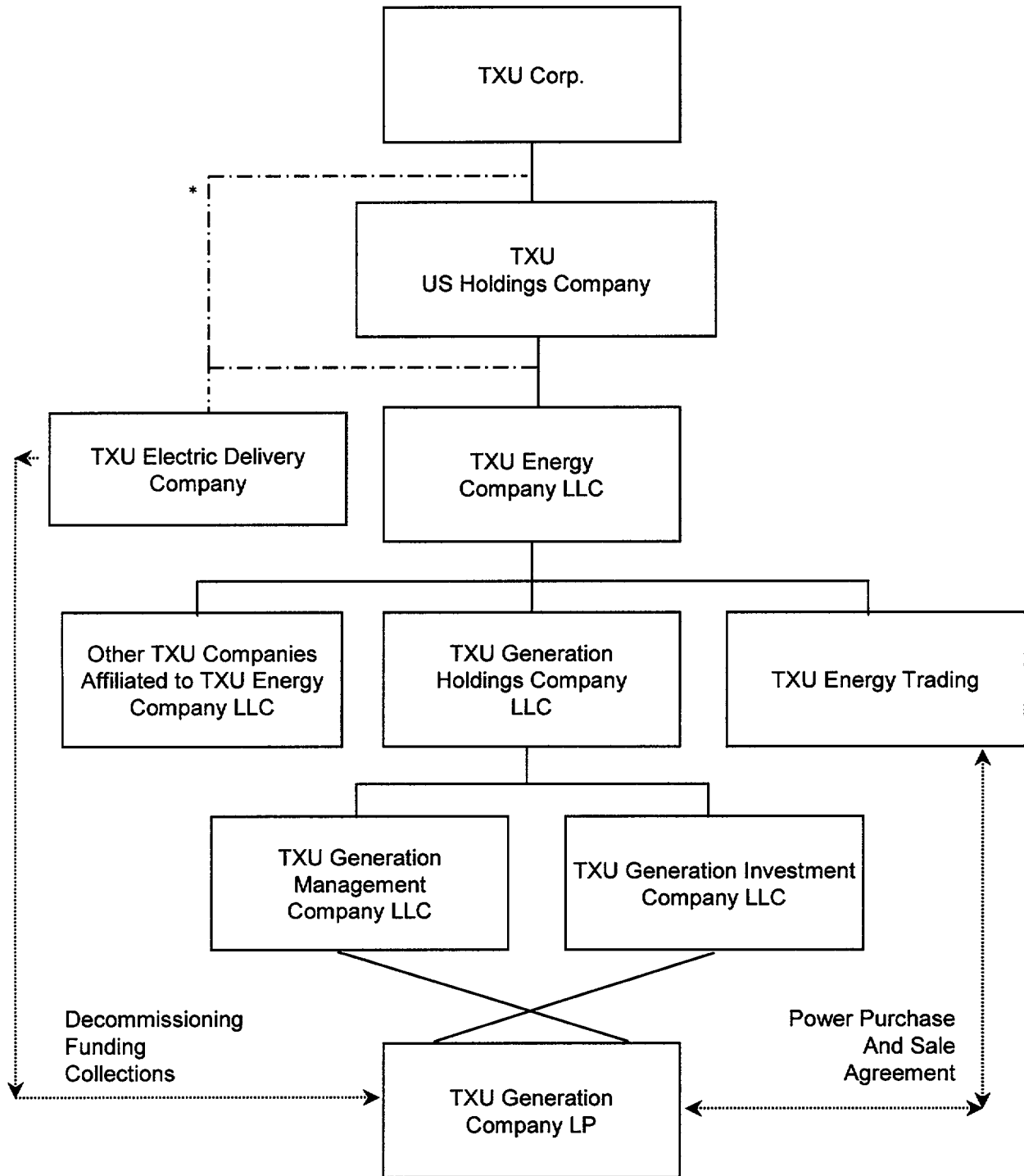
5. Description & Organization Chart for CPSES Nuclear Overview Function

The organization of the CPSES Nuclear Overview Function is shown in Figure 2. This figure shows the management structure and reporting relationships for CPSES, Units 1 and 2. In addition, the figure indicates that an independent review and audit function will be provided by the Nuclear Overview Manager who reports to the Senior Vice President & Principal Nuclear Officer via the Vice President and Deputy to the Senior Vice President & Principal Nuclear Officer.

6. Evidence of Transfer of TXU Electric's Interest in Nuclear Insurance for CPSES to TXU Generation Company LP

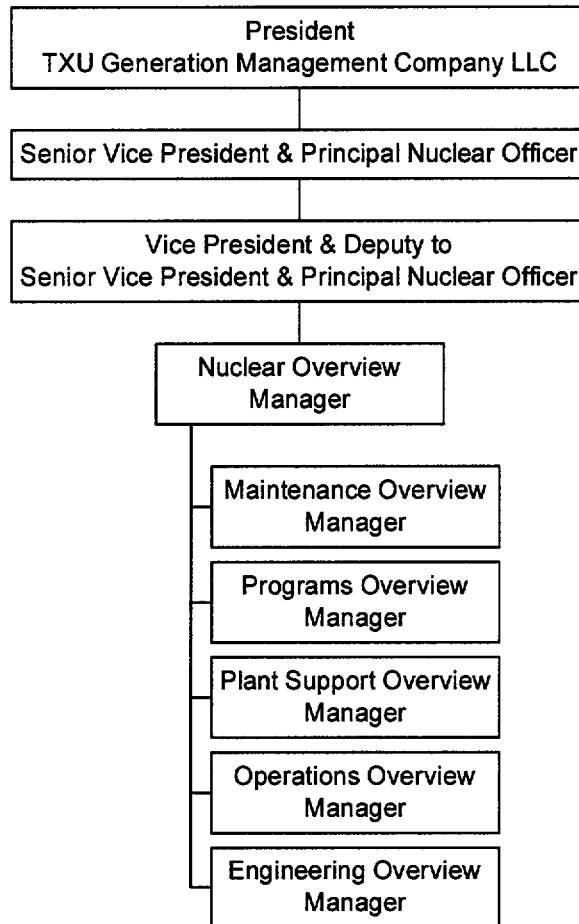

As requested, this confirms that the NEIL Board of Directors approved TXU's request that TXU Electric Company's Membership interest be transferred to a yet unnamed, wholly owned subsidiary of TXU Corp. The Resolution approved by the Board was as follows:

**RESOLVED**, that in connection with the transfer of TXU Electric Company's interests in the Comanche Peak Station to a new, as yet unnamed, indirect wholly owned subsidiary of TXU Corp., the Company will recognize the new subsidiary designated by TXU Corp. as the successor to the NEIL Membership of TXU Electric Company. Said transfer will take effect upon notice from TXU that the NRC has authorized the transfer of the owner/operator license for the plant and that the actual transfer has taken place.




**Re: Comanche Peak Steam Electric Station**

Dear Ira,

This letter confirms that ANI will make the following changes to the Comanche Peak nuclear liability insurance program. These changes will coincide with the license transfers from TXU Electric Company to TXU Generation Company LP. These insurances are purchased to comply with the financial protection requirements in Section 170 of the Atomic Energy Act of 1954, as amended.

- Under Policy No. NF-0274, ANI will change the Named Insured to *TXU Generation Company LP*. We also will amend the site description to reflect the new name.
- Under Master Worker Policy Certificate No. NW-0631, ANI will make the identical Named Insured and site description changes.
- Under Secondary Financial Protection Certificate Nos. N-0090 and N-0119, ANI will change the Named Insured to *TXU Generation Company LP*. Under each certificate, ANI also will amend each Bond for Payment of Retrospective Premiums, to designate *TXU Generation Company LP* as the named insured required to pay retrospective premiums.
