We have also begun a thorough review of our safeguards and physical security programs, including a comprehensive examination of the programs' basic underlying assumptions.

We agree with you that certain sensitive information does not belong on the web site and will be instituting permanent document management processes to ensure the release of such information is controlled. The decision on which documents to restore to our web site will challenge our long time practice of allowing the public open and convenient access to many of our activities.
