**PROGRAM MANAGEMENT INFORMATION: NOTICE OF OPPORTUNITY TO COMMENT  
ON DRAFT RULEMAKING PLAN, “10 CFR PARTS 30, 31, AND 32, EXEMPTIONS FROM  
LICENSING AND DISTRIBUTION OF BYPRODUCT MATERIAL; LICENSING AND  
REPORTING REQUIREMENTS” (STP-02-012)**

The Nuclear Regulatory Commission (NRC) is seeking comments\* from Agreement States on the draft rulemaking plan, “10 CFR Parts 30, 31, and 32, Exemptions from Licensing and Distribution of Byproduct Material; Licensing and Reporting Requirements.” This rule plan is a part of the systematic assessment of exemptions from licensing. The rulemaking would primarily address revisions to the exemptions from licensing in Part 30 and the requirements for exempt-distribution in Part 32. It will also address a few specific issues concerning making the regulations more flexible, user-friendly, and performance-based in the area of requirements for distributors of generally licensed devices as identified in [SECY-97-291](#). The compatibility designation for the proposed rulemaking plan is provided under the “Agreement State Implementation Issues” section. Because the Commission may give consideration to revising the compatibility category for §§ 32.11 and 32.12 to NRC, we request that you provide us with your comments and any potential impacts to include information on approximate number of licensees and type of product or material.

The draft rulemaking plan has been uploaded to the NRC’s Technical Conference Forum (TCF) under a subsystem where access is limited to Agreement States. Agreement States can access the draft rulemaking plan on the TCF at <http://techconf.llnl.gov/cgi-states/topics> using the appropriate user name and password which was last updated via All Agreement States letter SP-99-027. Due to its predecisional nature, this document is exempt from public disclosure under NRC rules. We request that you limit distribution to your staff and not release the document publicly. If the document is released, please inform me or the Point of Contact below within 24 hours.
