27 1. The Firm is Accountants and Financial Advisors to the Official Committee

17 9. The interim compensation and reimbursement of expenses sought in this  
18 Application is on account and is not final. Upon the conclusion of this case, the Firm will  
19 seek fees and reimbursement of the expenses incurred for the totality of the services  
20 rendered in the case. Any interim fees or reimbursement of expenses approved by this Court  
21 and received by the Firm will be credited against such final fees and expenses as may be  
22 allowed by this Court.

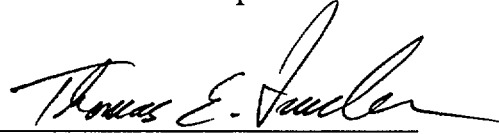
23 10. The Firm represents and warrants that its billing practices comply with all
