#### DISTRIBUTION OF THE WASTE PACKAGE MATERIALS PERFORMANCE PEER REVIEW FINAL REPORT AND NOTIFICATION OF OPEN MEETING

The Waste Package Materials Performance Peer Review Panel (Panel) will present the results of their final report in an open meeting at the J W Marriott Las Vegas on Monday, March 18 and Tuesday, March 19, 2002, from 8:00 a.m. to 5:00 p.m. and 8:00 a.m. to 12:30 p.m. respectively. The Yucca Mountain Site Characterization Project will provide an update on additional corrosion test data available and other selected topics. Copies of the final report from the Panel will be available at the time of the meeting and will be posted on the Yucca Mountain Site Characterization Office website (<http://www.ymrp.gov>). The final report documents the Panel's impressions of the program adequacy to assist the U.S. Department of Energy (DOE) in prioritizing future work plans. Panel recommendations will be provided to DOE to increase confidence in long-term performance projections.
