ELIMINATION OF THE EXECUTIVE COUNCIL

This memorandum is in response to Michael Springer's memorandum (Springer to Office Directors, February 21, 2002) requesting that NRR review a list of management directives to determine (1) those for which it is responsible and (2) if revisions are warranted as a result of the elimination of the Executive Council.

The only management directive on the list for which NRR is responsible is 8.8, Management of Allegations. This management directive is currently being rewritten; however, my staff reviewed the latest draft available and concluded that it does not require editing as a result of eliminating the Executive Council and the subsequent realignment of OCIO, OCFO, and the EDO. My staff also reviewed management directives not on your list to determine other instances of NRR responsibility. NRR could not find examples that would require editing pursuant to the realignment of organizational responsibilities under the EDO.
