Gentlemen:

Enclosed are the original and three copies of Change 1 to Revision 20 of the Waterford 3 Physical Security Plan (Enclosure 1) which is submitted in accordance with 10CFR50.4.

In accordance with 10CFR50.54(p), Entergy has evaluated the proposed changes and determined they do not represent a lessening of the effectiveness of the Security Plan. The Waterford 3 Onsite Safety Review Committee approved the plan change on January 30, 2002.

The change incorporates an option to use alternate means for verifying military service employment for allowing unescorted access. This option was a result of a Nuclear Energy Institute initiative that received NRC endorsement for Access Authorization Programs, with the stipulation that it be identified in the Licensee's Physical Security Plan. The change also makes an editorial correction to page "i".

Enclosure 1 contains safeguards information as defined by 10CFR73.21 and its disclosure to unauthorized individuals is prohibited by Section 147 of the Atomic Energy Act of 1954, as amended.


