


The purpose of this modification is to: (1) exercise Option Year Two in accordance with FAR Clause 52-217-9, "Option to Extend the Term of the Contract," which is hereby incorporated by reference, and Section F.4, "Duration of Contract Period," thereby extending the period of performance through March 12, 2003; (2) increase the contract ceiling amount by \$713,110.00 from \$1,385,500.00 to \$2,098,610.00, and increase the obligated amount by \$521,000.00 from \$775,000.00 to \$1,296,000.00; and (3) revise Section H.2, "Key Personnel." Accordingly, the contract is modified as follows:

1. Section F.4 DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 4 (JUN 1988) is deleted entirely and replaced with the following:

The ordering period for this contract shall commence on March 13, 2000, and will expire on March 12, 2003. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering.) The term of this contract may be extended at the option of the Government for an additional one-year.

2. Under Section B.4 CONSIDERATION AND OBLIGATION-DELIVERY ORDERS (JUN 1988), the first sentence in paragraphs (a) and (b) is deleted entirely and replaced with the following:

(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$2,098,610.

(b) The amount presently obligated with respect to this contract is \$1,296,000.00.

3. Section H.2 KEY PERSONNEL is revised as follows:

Delete the name "Stanley E. Ridley," and add the names "Karen McCluskey" and "Stanley Cooper." The names of all other "Key Personnel" remain the same.

All other terms and conditions of this contract remain unchanged.

A summary of obligations for this contract from the award date through the date of this action is given below:
