


Modification No. 7

The purpose of this modification is to: (1) revise the statement of work to incorporate additional work in accordance with the contractor's proposal dated October 8, 2001, which is hereby incorporated by reference, (2) increase the ceiling amount by \$350,000 from \$1,525,000 to \$1,875,000.00, (3) increase the obligated amount by \$175,000 from \$1,525,000 to \$1,700,000, and (4) extend the period of performance through December 31, 2002. Accordingly, the cooperative agreement is modified as follows:

1. The contractor shall perform the work described in the contractor's proposal dated October 8, 2001, is hereby incorporated by reference and made a part of this contract.
2. The period of performance of this contract is October 1, 1997 through December 31, 2002.

All other terms and conditions of this cooperative agreement remain unchanged.
