

The purpose of this contract modification is to allot incremental funds in the amount of \$200,000 to this contract and to designate a new NRC Project Officer. Accordingly, the contract is modified as follows:

1. \$200,000 is allotted to this contract. As a result, Section B.3 is replaced by the following Section B.3:

B.3 CONSIDERATION AND OBLIGATION--COST REIMBURSEMENT (JUN 1988) ALTERNATE I (JUN 1988)

- (a) The total estimated cost to the Government for full performance under this contract is 650,000.
- (b) The amount presently obligated by the Government with respect to this contract is \$450,000.
- (c) It is estimated that the amount currently allotted will cover performance through 11-30-2002.

2. Section G.1 of the contract is modified to substitute the name of Cayetano Santos in lieu of Carolyn Fairbanks as NRC Project Officer. His phone is 301-415-6004.

3. All other terms and conditions remain unchanged.
