However, in light of the events of September 11, 2001, and information that became available subsequently, we undertook a careful and deliberate review of all information contained on our existing web site to ensure that the site would not be a source of information helpful to terrorists. That review is not yet completed.

Nonetheless, I am pleased to inform you that the daily plant status report -- renamed the Power Reactor Status Report -- has been restored to the NRC web site as of March 15, 2002.
