Ken Karwoski will discuss a proposed Bulletin to ensure that operating facilities have performed appropriate CRDM nozzle/vessel head inspections or have developed acceptable justifications for continued operation of their facilities, following the discovery at Davis-Besse of axial through-wall indications in several CRDM nozzles and a degraded, triangular shaped area with a height of approximately 5 inches and a base of approximately 4 to 5 inches.

If time is left after that presentation and discussion, there will be a closed meeting to continue the Members discussion of future CRGR activities.

If a CRGR member cannot attend the meeting, it is his or her responsibility to ensure that an alternate, who is approved by the CRGR Chairman, attends the meeting. Persons making presentations to the CRGR are responsible for (1) ensuring that the information required for CRGR review is provided to the committee (CRGR Charter Section IV); (2) coordinating and presenting views of other offices; (3) as appropriate, ensuring that other offices are represented during the presentation; (4) forwarding an electronic copy of the presentation materials to CRGR staff (R. Spence) as soon as possible before the meeting; (5) providing 10 copies of presentation materials for distribution on the day of the meeting; (6) and ensuring that agenda modifications are coordinated with the CRGR staff and others involved with the presentation. Sponsoring Division Directors or higher management should attend meetings addressing agenda items under their purview.
