Dear Ms. Conley:

On October 2, 2001, Sattar Lodhi of this office visited your facility in response to your telephone call of October 2, 2001, informing this office that your personnel had removed an "EXIT" sign that had been damaged some time ago. Mr. Lodhi reviewed the handling of the damaged "EXIT" sign by your personnel, storage of the damaged sign, and your plans to dispose of the damaged sign. The device, an Isolite Model 2000 (Serial No. A49660) containing 7.5 curies of hydrogen-3 (tritium) was acquired by you under the general license in 10 CFR 31.5.

Mr. Lodhi collected samples from the personnel who handled the damaged sign, several spots at the damaged sign, the location where the sign was installed, nearby stairs and handrails, and the seat of the vehicle that was used to transport the damaged sign to your storage location. The collected samples were analyzed in our laboratory in Region I. Analysis of these samples did not indicate any significant contamination of your personnel, stairs, handrails or the transport vehicle. Mr. Lodhi also verified that you had appropriately stored the damaged device to prevent spread of contamination. From the telephone conversation on February 13, 2002, between you and Sattar Lodhi of this office we understand that you have transferred the damaged device to Isolite Corporation.
