As discussed in our letter of January 14, 2002, and its enclosed supplemental inspection report documenting our review of the Unit 1 failure of the No. 11 auxiliary feedwater pump turbine in May 2001, this additional discussion topic will satisfy Manual Chapter 0305, Action Matrix requirements to conduct a Regulatory Performance Meeting. In addition, the NRC staff will provide an overview of the NRC's Reactor Oversight Process.
