The purpose of this modification is to exercise Option Year Two in accordance with Section I.3, 52.217-9, Option to Extend the Term of the Contract (MAR 1989). As a result, Section F.5, DURATION OF CONTRACT PERIOD (MAR 1987), will be revised to extend the expiration date of this contract from April 6, 2002, to April 6, 2003. Accordingly, the contract is hereby modified as follows:

Section F.5, DURATION OF CONTRACT PERIOD (MAR 1987) Alternate 4 (JUN 1988), is deleted entirely and replaced with the following:

"The ordering period for this contract shall commence on April 7, 1998, and will expire on April 6, 2003. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering.)"

All other terms and conditions, including the ceiling amount of \$13,164,988.27, remain the same.
