TWENTY-DAY RESPONSE TO ORDER FOR INTERIM SAFEGUARDS AND
SECURITY COMPENSATORY MEASURES FOR SHEARON HARRIS NUCLEAR
POWER PLANT

Ladies and Gentlemen:

On February 25, 2002, the NRC issued a letter Subject: "Issuance of Order for Interim Safeguards and Security Compensatory Measures for - Shearon Harris Nuclear Power Plant." In the order, Section III, B. 1, the NRC requires that, within 20 days, that Carolina Power & Light (CP&L) Company's Harris Nuclear Plant (HNP) notify the NRC, (1) if CP&L is unable to comply with any of the requirements described in Attachment 2 of the order, (2) if compliance with any of the requirements is unnecessary in HNP's specific circumstances, or (3) if implementation of any of the requirements would cause CP&L to be in violation of any NRC regulation or the facility license. None of the above three listed conditions applies to CP&L at HNP.

Section III, B. 2 of the order requires CP&L to notify the NRC within 20 days if implementation of any of the requirements of Attachment 2 would adversely impact safe operation of the facility. Implementation of these requirements will not adversely impact safe operation of HNP.

Section III, C. 1 of the order requires CP&L, within 20 days, to submit to the NRC a schedule for achieving compliance with each requirement described in Attachment 2. The schedule for HNP is contained in the enclosure to this letter.

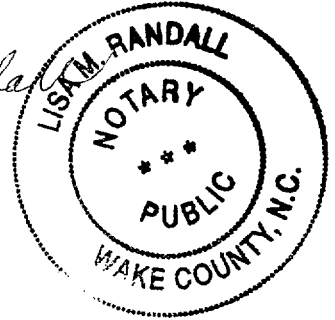
