The purpose of this modification is to provide incremental funding in the amount of \$43,000 to allow for the continuation of work in Option Year 2 , thereby increasing the obligated amount of this contract from \$397,899.00 to \$440,899.00. Accordingly, the contract is hereby modified as follows:

Under Subsection B.3, "CONSIDERATION AND OBLIGATION—COST PLUS FIXED FEE (JUN 1988)," paragraph (g) is deleted in its entirety and the following paragraph is substituted in lieu thereof:

"(g) The amount currently obligated by the Government with respect to this contract is \$440,899.00."

All other terms and conditions remain unchanged, including the ceiling amount of \$491,649.00.
