The U.S. Nuclear Regulatory Commission (NRC) hereby accepts the proposal of Sound Visions Integration dated March 14, 2002 and amended on March 19, 2002 and March 25, 2002, which is hereby incorporated by reference and made a part hereof this modification, to provide the NRC with additional integration support for the NRC's Incident Response Center's Audio/Video/PC Turnkey Switching System, due to a change in the Government's requirement. As a result, the firm fixed price of this contract is increased by \$24,885.60 from \$102,916.15 to \$127,801.75.

Accordingly, the following changes are hereby made:

Under Section B.5 - SCOPE OF WORK, is hereby amended to incorporate the following work due to a change in the Government's requirement. As a result, the contractor shall integrate additional NRC-provided equipment, in accordance with the following specifications with the Audio/Video/PC Turnkey Switching System:

- (1) *Two (2) 19" flat panel display units, inclusive of wall mounting hardware\**, shall be added to each of the existing two (2) corner units in the IRC, whereby the additional video output display units are required for emergency response implementation. In addition, *two (2) 23" flat panel display units, inclusive of wall mounting hardware\**, shall be added to the existing units in Room 514, whereby the additional video output display units are required for emergency response implementation. The vendor shall install the NRC-provided units and integrate them with the Audio/Video/PC Turnkey Switching System, revising as needed, the existing equipment and configuration to support the additional display units, including remote video control and switching, plus audio control and muting for the 23" units, consistent with section B.5 of the contract
- (2) Upgrade the wireless remote controls from 5.7" to 12" touch screens with an additional 2-Way RF Transceiver, which is required to provide a dedicated link to each remote control unit (the 12" remote controls will replace the not-yet-procured units and the transceiver will supplement the unit shown in Attachment 2 of the basic contract.)

- (3) Revise the signal sources and other equipment and configuration to allow simultaneous display of four satellite signals, and the Audio/Video Output from an *NRC-provided video conferencing system\**, supplying either component S-VHS or composite video and 2-channel audio signals. The additional inputs shall be integrated with the Audio/Video/PC Turnkey switching system and its configuration to support the additional inputs. Also, the contractor shall provide local wiring (to be specified by NRC) for the video conference camera/control unit at 4 locations back to the equipment rack room (The four locations are the two corner and center 50" screens in the Response Center and the 50" screen in the Conference Room).

As a result of the Government's requirement for the integration of additional Government furnished equipment with the Audio/Video/PC Turnkey Switching System, the contractor shall be required to make changes to the equipment to be acquired. Therefore, Attachment 2 of this contract is hereby deleted in its entirety and substituted in lieu thereof the Attachment to this modification.

2. Under Section B.12 - **Government Furnished Property**, is hereby revised to incorporate the following equipment:

"B.12 GOVERNMENT FURNISHED PROPERTY

- "(4) Two (2) 12" Flat Panel Display Units inclusive of wall mounting hardware
- (5) Two (2) 23" Flat Panel Display Units inclusive of wall mounting hardware
- (6) Video Conferencing System"

3. Under Section B.2 - **Consideration and Obligation**, is hereby deleted in its entirety and substituted in lieu thereof the following:

"B.2 **CONSIDERATION AND OBLIGATION**

The firm fixed price of this contract is \$127,801.75."
