Dear Sir/Madam:

On behalf of our children and ourselves, we would like to express our general opposition to the above NRC licensing application (and the application for a BLM right-of-way) for an independent spent fuel storage facility (ISFSF) in Skull Valley, Utah, unless the staffs of the NRC, BLM, STB and BIA properly assess and consider the environmental impacts in compliance with the National Environmental Policy Act of 1969 (NEPA) and applicable CEQ and NRC regulations, including 40 CFR 1500 *et seq.* and 10 CFR Parts 51 and 72, and NUREG 1567. We request that the NRC, BIA, STB and BLM deny the licensing and right-of-way applications unless or until their respective staffs remedy the defects in their FEIS.

First, it is not clear from the FEIS which of the four agency regulations controlled the preparation of the document, but it appears the FEIS does not comply with at least some of all the respective agency regulations. As drafted by the NRC, BLM, BIA and STP, the final environmental impact statement (FEIS) fails to comply with NEPA, the CEQ regulations, and the NRC regulations in a number of areas. Our concerns focus on, but are not limited to, the lack of an adequate assessment of the hydrogeology of the site and transportation areas and the impacts to groundwater quality. Some of our specific concerns follow:

- NEPA requires that EIS mitigation plans be described in "sufficient detail" to allow the decision maker to properly consider whether the mitigation will minimize adverse impacts. Although the Skull Valley FEIS states that someday, someone, somewhere, may prepare a groundwater monitoring plan to mitigate the groundwater impacts,¹ we are unable to find any details of this hypothetical monitoring plan in the FEIS itself. The material terms of the hypothetical monitoring plan must exist before they can be considered by the decision maker.
- NEPA requires, and the CEQ and NRC regulations state that issues identified in the EIS scoping document will be analyzed in detail. One issue identified in the scoping document is groundwater quality. As near as we can tell, the FEIS contains only one

paragraph pertaining to groundwater quality, and it only makes a vague reference to groundwater quality apparently taken from an old reconnaissance report. This single paragraph,² without any site specific groundwater quality data fail to satisfy the "detailed" analysis mandated by NEPA and NRC regulations.

- Among other things, NRC regulations require that EISs comply with the requirements of Part 72, Subpart E. Clearly one paragraph on groundwater quality, without any site specific data, or assessment is insufficient to comply with Part 72, and the applicable parts of NUREG 1567, including §§ 2.4.5 and 2.5.5.
- The applicant places far too much reliance on the integrity of its storage canisters to prevent spills or releases of radiologics. Although the NRC may have a policy of limiting safety concerns under the Atomic Energy Act to "credible" accidents, we do not believe NEPA and the related NRC environmental regulations allow such a limitation., i.e., releases of radiologics and non-radiologics should be assumed to occur even if the exact release mechanism is unknown. Put another way, NEPA requires an assessment of impacts from releases of radiologics and non-radiologics, not an analysis of *how* a release may occur. Intentional or unintentional releases are an assumed event, and therefore should be part of the groundwater quality analyses.
- NRC environmental impact guidance for ISFSIs states that, if a groundwater production well is to be placed onsite then the aquifer, its different hydrologic units, and the specific hydrogeology of the site, as well as groundwater fate and transport modeling should be assessed and performed. See e.g., NUREG 1567 §§ 2.4.5, 2.5.5., 2.5.4.9. Clearly the FEIS fails to include any information of this type, not to mention why this hydrogeologic information is absent from the FEIS. CEQ regulations are clear that the absence of information and data should be discussed and unless the cost of acquiring the information is exorbitant, the information should be acquired.
- Finally, the FEIS is required to discuss the good with the bad, i.e., the EIS should not discuss only the information which supports the proposal. This the FEIS fails to perform, especially in the context of hydrogeology and groundwater quality. For example, the FEIS indicates the native surface soils are allegedly of low permeability and will prevent infiltration of spills and releases to the groundwater. Among other things, the FEIS fails to adequately note that there is no site specific data to support that conclusion; that there are dozens of open or improperly sealed boreholes across the site which may act as direct conduits to the groundwater (or zones just above the groundwater); that soil types vary widely across the site, and therefore, so will the hydraulic conductivity of the soils; and that without site specific data, there simply is not enough data to reach *any* scientifically supportable conclusion regarding the hydrologic connection between the surface soils and the groundwater.

None of the above *factual* information is new and was known to the staffs because it is in the applicant's submittals (or is the position of the applicant). We appreciate your consideration of the above concerns and recommend that the NRC, BLM, STB and BIA



As a Utah resident I wanted to take the opportunity to respond to the proposed use of the Skull Valley Reservation as a dumping ground, albeit temporarily, for high-level nuclear waste.

I am adamantly opposed to not only storing high-level nuclear waste anywhere in Utah but I am equally opposed to transporting it through this state. My response is primarily based on two ideas which are linked to each other: 1) the inherent danger of nuclear waste (radiation) and 2) the environmental impact on lands under consideration for wilderness designation in the America's Redrock Wilderness Act (especially the Cedar Mountain unit).

Dear sirs of the Nuclear Regulatory Commission,

I am writing today to voice my strong objection to the proposal for a temporary storage facility of spent nuclear fuel to be located in skull valley Utah. My main objection is regarding the lack of planning that this proposition is built upon. If this material is stored here it will be only after vigorous litigation. Furthermore, before it could ever depart there would be a lot more litigation. I am not completely opposed to this material finding its final resting place at that facility, but it should be licensed as a permanent repository if there is even the remotest chance that is what it will become. The lack of thorough planning regarding the site is not the biggest problem however. The transportation of the material itself seems to be the part of the plan with the most risk and the least assessment of that risk. In the Draft Environmental Impact Statement for the site transportation risks were not addressed. To my knowledge that is how they remain today. Considering that tests of the storage casks omitted the effect of sabotage or use of weapons such as tank killing shape charges, moving this material now would create an uncertain level of risk to thousands of miles of open space and dozens of cities. With transportation corridors stretching virtually from one side of the nation to the other, the opportunity for a ready made radiological weapon would become an all to real threat to many metropolitan areas and waterways across our country.

I understand that there are risks associated with leaving spent fuel where it is in the densest population centers of America. It is further understood that onsite storage is rapidly running out. Left unaddressed this could result in the premature decommissioning of several power plants. But there is an alternative. If more money were invested in fast breeder reactor technology then we could develop a path towards truly eliminating this high level waste. And at the time that technology reaches fruition this material, which would then again be fuel, would need to be exactly where it is now, at the power plants where it can effectively be safe guarded. Not spread across the country in rail yards, not in the Utah desert and not underneath Yucca Mountain in Nevada.

In closing I would urge you to avoid creating such a blatant target for terrorism. Our enemies have proved themselves adept at exploiting resources to make weapons of mass destruction. Lets not hand them the means to permanently poison the cities of their choice. Thank you for your time and consideration.

To Whom It May Concern,

I strongly object to the storage of nuclear waste in the State of Utah for the following reasons:

1. while it currently appears that this could be accomplished safely, history has shown that unanticipated, serious problems may show up in the future. Since the waste may be active and dangerous for several thousand years the cost of a future cleanup may be prohibitively expensive and could easily ruin the economy of the State of Utah and its neighbors.
2. since the true cost of storing and maintaining a storage site for nuclear waste is not well known nor understood it is impossible to determine a fair compensation to the owners of the proposed site and the residents of the State of Utah. The future costs to the State resulting from storing this nuclear waste could be significantly higher than any revenue generated directly or indirectly from this transaction. It is the responsibility of the government to protect its citizens from any unfair exploitation and thus the government should not allow the storage of such materials in the State of Utah unless it also agrees to hold Utah and its residents harmless (directly and indirectly) for any future costs associated with the storage of such nuclear waste.
3. for the reasons outlined above the government should not allow the generation and disposal of any such nuclear waste unless the party responsible can be held accountable and can demonstrate its ability to pay for all future costs associated with maintaining a suitable storage site for such waste.
4. the preferred method of disposing of waste already generated is to pay foreign countries to dispose of such waste, where no liability will be incurred by the US and its citizens. Further, no future activities that generate such waste should be allowed unless the party generating such waste has an approved plan and financing in place to dispose of such waste.

I ask that the above be considered in opposition to any plans to move and storage nuclear waste in the State of Utah.


