The purpose of this modification is to exercise the contract option to extend the contract period of performance and provide additional funds. Accordingly, the following changes are hereby made:

1. Section F.6 DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 2 (MAR 1987) is revised to extend the contract period of performance through September 30, 2002. At the option of the Government, the contract may be extended beyond September 30, 2002 through April 24, 2003, upon the execution of a bilateral modification. Therefore, Section F.6 is revised to read as follows:

"This contract shall commence on April 25, 2001 and will expire on September 30, 2002. The term of this contract may be extended, at the option of the Government, through April 24, 2003."

2. Section B.3 CONSIDERATION AND OBLIGATION --- COST PLUS FIXED FEE (JUN 1988) ALTERNATE I (JUN 1991), paragraph (c), first sentence is deleted and substituted with the following in lieu thereof:

" (c) The amount currently obligated by the Government with respect to this contract is \$350,000.00, of which \$329,543.00 represents the estimated reimbursable costs, and of which \$20,457.00 represents the fixed fee."

A summary of obligations for this contract, from date of award through the date of this action, is provided below:

FY01 Obligation Amount:	\$190,000.00
FY02 Obligation Amount:	\$160,000.00
Cumulative Amount:	\$350,000.00

This Modification No. 2 obligates funds in the amount of \$160,000.00.

All other terms and conditions remain the same.
