


The purpose of this modification is to deobligate funds in the amount of \$20,515.00 from the subject contract, thereby decreasing the obligated and ceiling amount from \$246,268.00 to \$225,753.00.

Accordingly, the following changes are hereby made:

Under Paragraph B.8 - **CONSIDERATION AND OBLIGATION**, the first sentence of Subparagraphs (a) and (b) are hereby deleted in their entirety and substituted in lieu thereof the following:

"B.8 CONSIDERATION AND OBLIGATION

- (a) The total estimated amount of this contract is \$225,753.00.
- (b) The amount presently obligated with respect to this contract is \$225,753.00."
