

## SUMMARY OF INFORMATION COLLECTION REQUEST

Title: 10 CFR 32, "Specific Domestic Licenses to Manufacture or Transfer Certain Items Containing Byproduct Material," Clearance Extension

Current Burden/Responses: 149,739 hours/32,585 responses

Proposed Burden/Responses 151,644 hours/4,187 responses (3,502 + 685 recordkeepers)

Burden Attributable to Third-Party Collections: 989 hours

Frequency of Response: On occasion, quarterly, 10-year renewal

Reasons for Changes in Burden/Responses:

The increase in burden hours is a result of an increase in the number of licensees from 598 to 685 licensee that are subject to Part 32 requirements, the changes made in the final amendments to 10 CFR Parts 30, 31, and 32 titled, "Certain Generally Licensed Industrial Devices Containing Byproduct Material;" and based on current information in NRC's General Licensee Tracking System database and other available information, the number of licensees who must comply with Sections 32.51 and 32.52 has been revised and the burden increased accordingly for these sections. The main increases are for section 32.51(a)(3) (1213 hours [25 additional licensees X 48.5 hours]) and section 32.52(a) and (b) (1250 hours [2500 additional licensees X .5 hours]). In addition, the number of responses has been reduced by 28,398 primarily because the information collection requirements in sections 32.51a(a) and 32.51a(b) and 32.52(a) and (b) were previously erroneously listed as reporting requirements, but have been moved to the recordkeeping tables in this clearance renewal. Additionally, the number of recordkeepers has been added to the number of responses.

Abstract:

Part 32 establishes requirements for specific licenses for the introduction of byproduct material into products or materials and transfer of the products or materials to general licensees or persons exempt from licensing. Requirements are for information which must be submitted in an application for a specific license, records to be kept, reports to be submitted, and information which must be forwarded to general licensees and persons exempt from licensing. In addition, 10 CFR Part 32 prescribes requirements for the issuance of certificates of registration (concerning radiation safety information about a product) to manufacturers or initial transferors of sealed sources and devices. The information is used by NRC to make licensing and other regulatory determinations concerning the use of radioactive byproduct material in products and devices.
