**JOINT REPORT ON SCHEDULE
FOR FINDINGS OF FACT AND FINDINGS OF
FACT (RESPONSES) FOR CONTENTION SUWA B**

Applicant Private Fuel Storage, L.L.C. ("Applicant" or "PFS"), the NRC Staff ("Staff"), and Southern Utah Wilderness Alliance ("SUWA") submit the following report to the Atomic Safety and Licensing Board ("Board") on their agreement with respect to the schedule for filing finding of fact and findings of fact responses for Contention SUWA B.

In its Memorandum and Order (Revised General Schedule), dated September 17, 2001, the Board adopted a revised general schedule for the proceeding, including a schedule for the submission of findings of fact and findings of fact (responses) for all the then outstanding contentions. While the then anticipated schedule for hearings on contentions Utah K/Confederated Tribes B and Utah L (subsequently consolidated with contention Utah QQ) has proven to be optimistic, the hearings on contention SUWA B were completed within the schedule set forth in the September 17, 2001 Memorandum and Order. As a result, PFS, the Staff and SUWA hereby inform the Board that they will adhere to the schedule set forth in that Memorandum and Order with respect to the submission of findings of fact and reply findings,




