SUBJECT: Withholding Information From Public Disclosure

Dear Mr. Roberts:

By the UniTech Services Group (UniTech) letter dated April 26, 2002, and the affidavit of that same date, UniTech submitted information related to the schedule for direct release of effluent to the river. In this letter, UniTech requested that certain information related to UniTech's wastewater treatment system be withheld from public disclosure pursuant to 10 CFR 2.790. UniTech stated that a limited portion of the April 26, 2002, submittal contained in Attachment A, should be considered exempt from mandatory public disclosure for the following reasons:

1. The information is proprietary commercial property and has been held in confidence by UniTech and all parties and agents involved by executing written confidentiality agreements.
2. The information, notably site-specific design, processes, and methods are normally held in confidence by UniTech.
3. Public disclosure of the information is likely to cause substantial harm to the competitive position of UniTech. The acquisition of this information represents a substantial financial investment by UniTech. The results of these efforts are unique and vital to the continuing competitive position of the company, and public disclosure would provide an economic windfall to competitors.

We have reviewed UniTech's application and the material in accordance with the requirements of 10 CFR 2.790 and, on the basis of your statements, have determined, after consultation with the Region I Regional Counsel, that the submitted information sought to be withheld contains proprietary commercial information.

Therefore, the portions of the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.790(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.

Withholding from public inspection shall not affect the right, if any, of persons properly and directly concerned to inspect the documents. If the need arises, we may send copies of this information to our consultants working in this area. We will, of course, ensure that the consultants have signed the appropriate agreements for handling proprietary information.

If the basis for withholding this information from public inspection should change in the future such that the information could then be made available for public inspection, you should promptly notify the NRC. You also should understand that the NRC may have cause to review this determination in the future, for example, if the scope of a Freedom of Information Act request includes your information. In all review situations, if the NRC makes a determination adverse to the above, you will be notified in advance of any public disclosure.
