(Schedule for Responses to Request to
Participate as Interested Governmental Entity)

The Licensing Board is in receipt of the August 16, 2002 request of the California Energy Commission (CEC) to participate in this proceeding as an interested governmental entity pursuant to 10 C.F.R. § 2.715(c). Previously, the Board has received similar requests from San Luis Obispo County, California, (SLOC) and the Port San Luis Harbor District (PSLHD). In an August 7, 2002 memorandum and order we directed that any governmental entity seeking to participate under section 2.715(c) and wishing to raise issues other than those already proffered in the contentions filed on July 19, 2002, by petitioners San Luis Obispo Mothers for Peace, et al., (collectively SLOMFP) must do so on or before Wednesday, August 21, 2002. This would include CEC.

Responses to the CEC request to participate under 10 C.F.R. § 2.715(c) should be filed on or before Monday, August 26, 2002, unless CEC submits additional issues, in which case

responses to its participation request should be filed on Wednesday, September 4, 2002, in conjunction with any response to the issues filed.
