During the prehearing conference, the Licensing Board will hear arguments from the participants on the issues of the standing of the petitioners who are seeking a hearing and the admissibility of the contentions those petitioners have submitted.

If any of these petitioners subsequently is found to have standing and to have submitted one or more litigable

contentions, the Board will issue a notice of hearing that, in accordance with 10 C.F.R. § 2.715(a), will afford members of the public an opportunity to provide written or, as appropriate, oral limited appearance statements on the issues. The Board will issue a further notice outlining the times, places, and conditions of participation in the event the Board provides an opportunity for oral limited appearance statements.
